Mindy Hammond spoke on behalf of the Brisben Fire Department members that were present. They would like to install a new LED sign at their station. The Town of Greene currently has a six (6) month moratorium in effect until June so the Planning Board can create a law on LED signage. A discussion followed, Planning Board Member Michelle Day suggested they contact the NYS Department of Transportation.

Michelle also stated the Planning Board has three (3) Public Hearings which will be held on March 23rd starting at 7:00 PM on Rapp Signs, Tractor Supply and On Common Grounds.

The Planning Board referred Bob Hofman to the Department of Conservation for information on mining and gravel pits for his project on County Road 32. The Planning Board will hold a work session on the Town of Greene Solar Law. Community members may attend, however, no public comments can be made.
