Village Board Meeting March 8, 2021

Mayor Brown called the meeting to order at 7pm with the Pledge of Allegiance. Trustee Hartley, Maley, Tuttle and Najarian were present along with Clerk Treasurer Irene A. Tornillo, SP Operator Ingraham, Electric Supt. Livingston, Equipment Operator Dedrick and Officer Nordberg. Those attending in Zoom meeting were: OIC Messina and Marcia Miller.

Motion to accept minutes of 1/28, 2/4, 2/8, 2/11, 2/25 and 3/4/2021 by Trustee Hartley second by Trustee Najarian. Ayes-all. Carried.

Motion by Trustee Tuttle second by Trustee Maley that the Treasurer's, Police, Code Enforcer's Report, Registrar Vital Statistics Report were received and filed. Ayes-all. Carried.

Electric Superintendent Livingston reported his crew is continuing tree cutting and maintenance of equipment.

Public Works Equipment Operator Dedrick reported Randy Neubauer passed his CDL test and will get his license changed right away. Trustee Najarian stated Public Works crew will be having OSHA/PESHA online training 3/11, 3/18 and 3/23/2021.

Sewer Plant Operator Ingraham requested a 30 day referendum for a new work truck for an approximate price of \$53,997.00, from reserve accounts G.9950.913 Sewer truck of \$18,000.00 and F.9950.911 Water Dept Truck of \$17,371.00, as well as money from budget line for the receiving tank money. SPO stated the receiving tank money is in a budget line item which if not used this budget he will lose it. There is a dealership that has a truck with a yard box and the GVW needed which will be capable of handling loaded truck as well as ability to haul the skid steer. Motion by Trustee Tuttle second by Trustee Maley to not exceed \$54,997.00. Ayes-all. Carried.

SPO Ingraham requested a 30 day referendum for control panel lift station 2 from ACI at \$23,761.77. Last year's budget it was agreed to pay from reserve accounts G.9950.911 Plant Equipment account and G.9950.915 Other Equipment account. This will be paid as a 3 part payment of under \$10,000.00 each. Motion by Trustee Tuttle second by Trustee Hartley not to exceed \$24,000.00. Ayes-all. Carried. On 3/9/2021, the Water Dept. crew will be repairing the service leak on N. Canal St that is leaking. There should be no disruption to the sidewalk or street.

Officer Nordberg is looking for board approval of the reform resolution, executive order 203 from zoom meeting of 3/1/2021 in order to send it to New York State which is due by 4/1/2021. Motion to approve police reform resolution by Trustee Maley second by Trustee Najarian. Ayes-all. Carried. Mayor Brown thanked Officer Nordberg and OIC Messina for putting it together.

Motion to appoint Election Inspectors, Jennifer Fowler, Merelyn Rogers, Shirley Girton and Sharon Baldo by Trustee Hartley second by Trustee Maley. Ayes-all. Carried.

Mayor mentioned upcoming election 3/16/2021 Tuesday, in the Village Office, 49 Genesee St., Noon to 9pm. Equipment Operator Dedrick stated the ramp will be installed by the election date.

Trustee Tuttle thanked SPO Ingraham for finishing up all the reporting to the Susquehanna River Basin Commission.

Trustee Najarian stated the backhoe is going back to be repaired by Five Star Equipment. The same seal is leaking. Town of Greene will be trucking the backhoe, for the Village, to Five Star Equipment for the repair.

Mayor Brown thanked Trustees and Supervisors for their work on the budget. Next budget meeting will be Thursday, 3/11/2021 at 6pm to finalize numbers for budget.
