

Village Board Meeting  
July 12, 2021

Mayor Brown called meeting to order at 7pm with the Pledge of Allegiance.

Present at meeting were: Trustees Najarian, Tuttle, Hartley, Trustee Shapley, SP Operator Ingraham, Working Supervisor Kinney, Electric Superintendent Livingston. Visitors: Rod Andrews, Marcia Miller.

Motion to accept special meeting minutes of 6/23/21 and Board meeting minutes of 6/14/21 by Trustee Tuttle seconded by Trustee Najarian. Ayes-all. Carried.

Motion by Trustee Hartley seconded by Trustee Shapley to accept the Treasurer's, Police and Registrar Vital Statistic reports. Ayes-all. Carried.

Trustee Shapley reported the fire rescue truck has been delivered to Candor, NY for final additions. There is no estimated time of delivery yet.

Motion by Trustee Hartley seconded by Trustee Tuttle to allow Superintendent Livingston to be voting delegate and attend MEUA conference in Celoron, NY August 31, 2021 thru September 3, 2021. Ayes-all. Carried.

Working Supervisor Kinney reported highway department has been cleaning manholes and cleaning up tree damage from storms. Hwy department has materials for sidewalk work and catch basin work ready for when weather clears. All tree stumps have been removed. All seeding except at Frontier on N. Canal St. is completed.

Sewer Plant Operator Ingraham thanked Bruce, Trustee Tuttle, Officer Commesso and Mayor Brown for their assistance with the main sewer line blockage issue Friday night. SPO Ingraham mentioned addressing residents of not throwing grease down drains.

Motion by Trustee Hartley seconded by Trustee Shapley to allow police department to buy back ammo to RJW Sales. Ayes-all. Carried.

Motion by Trustee Najarian seconded by Trustee Tuttle to allow Irene and Dedra to attend the NYCOM fall training conference in Saratoga Springs, NY Sept. 20 – Sept. 24, 2021. Ayes-all. Carried.

Mayor Brown read a letter from Attorney Larkin thanking the village staff for allowing him to serve the community as Village Attorney over the last 47 years.

Motion by Trustee Hartley seconded by Trustee Tuttle to accept quote for office construction to be done by Dorchester Farm Jack of All Trades. Ayes-all. Carried.

Motion by Trustee Najarian seconded by Trustee Shapley to allow Greene Labor Day fireworks on 9/6/21 between 8:45 and 9:15pm. Ayes-all. Carried.

Mayor reminded that July 24, 2021 will be Craft Fair day in the Village of Greene. There will be ample police coverage on Craft Fair Day.

Motion by Trustee Hartley seconded by Trustee Shapley to pay authorized payments of audited claims in the amount of \$70,365.30.

Motion by Trustee Tuttle seconded by Trustee Najarian to authorize budget amendments. Ayes-all. Carried.

Marcia Miller showed concern of installed "shed" on Foundry St. Code Officer Wheelock is addressing the issue and Mayor Brown has been in contact with him. Labor Day festivities moving along.

Trustee Hartley reported electric work on N. Chenango St work is completed.

The Ford pick-up truck is ordered for the Electric department.

There will be a Rabies Clinic on 7/31/21 at the Ballflats.

There will be a Memorial Service for Wayne Cook on Sunday 7/18/21 on the Ballflats.

There is a Ballflats meeting on Wednesday 7/14/21.

Mayor thanked Superintendent Livingston for clearing trees near bridge at Ballflats entrance. Cherry Street trees will need to be trimmed at the corner. Village will be address homeowners about tree trimming on their property.

Trustee Shapley announced our new office employee started Monday.

Trustee Tuttle reported SPO Ingraham has been diligently working on the permitting for well 3.

Thanked Bruce and Steve for their help Friday night with main sewer line clog. Tenants have been advised to notify their Landlords so they can contact their insurance carriers. The Village has sent courtesy letters to the Landlords of these properties.

Motion by Trustee Hartley seconded by Trustee Tuttle to close meeting and enter into executive session at 7:35pm.

Motion by Trustee Najarian seconded by Trustee Shapley to end executive session and enter into regular session at 7:52pm. Ayes-all. Carried.

Motion by Trustee Shapley seconded by Trustee Hartley to adjust summer Holiday hours as Memorial Day, July 4<sup>th</sup> and Labor Day be paid based on departments summer hours of 9 or 10 hour workdays and on a 4 or 5 day work week. Ayes-all. Carried.

Motion to adjourn by Trustee Tuttle seconded by Trustee Najarian at 8:10pm. Ayes-all. Carried.
