# Regular Town Board Meeting June 9, 2021

The regular meeting of the Greene Town Board was held on June 9, 2021 at 6:00 PM at the Town Hall, 51 Genesee St. Greene, NY 13778.

Joe Henninge called the meeting to order at 6:00 PM and led the Pledge of Allegiance.

#### **MINUTES**

Nick said that NAPA does not send them to us, we must request them.

Debbie suggested Adam should get a receipt from NAPA when he picks up parts/supplies and drop it off to the Town Clerk's office like he does with the Mirabito gas receipts.

### **COMMITTEE REPORTS**

Steve Page reported the JRC T-Ball and Softball programs are over. The JRC summer program is moving forward. Registration forms have been sent home with the students.

Steve Page suggested that during the spring and summer months the porta-johns should be dumped more frequently.

Steve is going to talk to Wayne Hartley to go over the procedure for processing the Ball flats use applications and monies. The Town Clerk's office will file the applications and process the fees.

Joe updated the board on the Williamson Law software progress, tutorials are scheduled for next week. Nick commented that he looked it over and does not think it's anything he needs. Mary is going to look into whether it would be compatible with the licensing programs the clerk's office currently uses.

A letter was received from Senator Akshar regarding the Sam Grant. Steve Page noted we're waiting on the approval, there is no money in hand.

#### **BOARD DISCUSSION**

Steve Northrup and Bernie McDermott had some questions for Joe regarding the Court audit. Joe noted the Audit was okay.

Debbie asked if the Town could purchase a calculator for the Treasurer of the Town of Greene Historical Society. The cost would be no more than \$50.00.

MOTION by Henninge, seconded by Northrup to approve the purchase. Ayes carried.

Nick has received concerns and comments on road signs on lanes and privately owned lake roads. Nick's concern is how will Fire and EMS identify these locations if not marked. Steve Northrup asked if Nick would check with Matt Beckwith to see if there is any legislation on lane signs.

Joe discussed his concerns with 5G towers coming into the town and asked Michelle and the Planning Board to review the Cell Tower Law. Michelle said they would take a look at that.

Michelle met with Altas over the concern of the steep slope, Planning Board is working through that.
