

**TOWN OF GREENE  
Regular Town Board Meeting  
October 14, 2020**

The regular meeting of the Greene Town Board was held on the above date at 6:00 PM at the Greene Town Hall, 51 Genesee Street, Greene, New York 13778.

Supervisor Henninge opened the meeting at 6:00 PM with Council Member Flanagan leading the Pledge of Allegiance.

**MINUTES**

**MOTION** by Northrup, seconded by Page to approve the minutes dated September 16, 2020 as submitted by the Town Clerk. Ayes all. Carried.

Supervisor Henning explained the Chenango County Hazard Mitigation Plan update for the Town of Greene. We have a medium threat for severe storms and can respond quickly except for flooding. We have increased the size of box culverts and added rip rap to help with the flooding.

**MOTION** by Northrup, seconded by Page for Supervisor Henning to send a letter to Community Solar Energy System requesting a PILOT (Payment in Lieu of Taxes) agreement according to NYS Consolidated Laws, Real Property Tax Law 487. Ayes all. Carried.

The Town received a petition from the residents of Crestmont Road and Turner Street for a reduced speed in their development. The Town will submit the request to the County and State.

**RESOLUTION** by Flanagan, seconded by Northrup to submit the request from the residents of Crestmont Road and Turner Street for reduced speed signs to Chenango County Department of Public Works Director Shawn Fry. Ayes all. Carried.

**MOTION** by Flanagan, seconded by Northrup to transfer \$5,000 from Equipment Account #A1680.2 to Contractual Account #A1680.4. Ayes all. Carried.
