Motion by Trustee Najarian, seconded by Trustee Maley that the Treasurers, Code Enforcement, Police, Assessor's and Registrar of Vital Statistics were received and filed. Ayes-all. Carried.

Fire Chief Phil Mirabito spoke to the board that the Fire Department was notified on Friday April 10th that they had been awarded the \$5000.00 mini grant for a dryer.

Rick Woerter spoke about the fire rescue truck in which they had scene lights put on top which brought the price over the approved amount of \$400,000.00. The truck committee asked Tri – Star to take the lights off but to leave the location mounts and the wiring bringing the cost down to \$396,000.00.

Motion by Trustee Maley, seconded by Trustee Najarian to approve the Freightliner M2 106 with a 350 engine with a delivery date no more than 1 year from signature of contract at a cost of \$396,000.00. Ayes-all. Carried.

Mayor Brown spoke about bids being opened for the ambulance but the bid that was received after 12pm public notice stated it had to be before noon, so it was decided to rerun the bid again in The Evening Sun and The Binghamton Press and open them at the May board meeting.

Working Supervisor Bruce Kinney said they are going to get the benches out to be put around the village. Also, the Highway department is going to pour some concrete.

Sewer Plant Operator said that they will be doing hydrant flushing next week and they will be sending out pamphlets.

Motion by Trustee Maley, seconded by Trustee Hartley to hire Police Officer Austin Wheeler parttime. Ayes-all. Carried.

Officer in charge Jeff Messina reminded the board that the winter parking ban was no longer in effect it expired April 1.
