The ladder truck is schedule to have changes made so it can be back in service. Mang Insurance quote came in \$150.00 less than VFIS for illness and reimbursement for loss of pay still checking the numbers. Fire Chief Rick Woerter wanted to thank the board for the many years of allowing him to serve the community of Greene as their Fire Chief. The board wanted to thank Rick for all he has done as the Fire chief and to wish him well in his next endeavors.

Working Supervisor Bruce Kinney gave an update on Birdsall Creek he had spoken to Shawn Fry at Chenango County and they would not be able to do the whole job maybe lend a truck and a guy depending on the time and what the county had going on. FEMA representatives have taken pictures walked the area and they could fund 75% with the state funding 12.5% and the village funding the 12.5%, FEMA is due back sometime this week. The highway department is going to have a work study student from BOCES come in the week of March 11th-15th or the week of March 18<sup>th</sup> -21<sup>st</sup>.

Sewer Plant Operator Steve Ingraham said that he is working though the waste water plant warranty claims.

Officer in Charge Jeff Messina told the board that he received a call at home that there was a burglary in progress in the village on 2/18/19, the closes Sheriff car was Norwich, so Officer In Charge Messina responded. Jeff did witness a burglary in progress and with the help of other responding units arrested a man for numerous charges burglary, gun possession, stolen property etc. Officer in Charge Jeff Messina wanted to let village residents know that the parking ban is still being enforced and it is effective until April 1, 2019. Last Thursday March 7, Jeff was in Binghamton at a BOSAR (Behavior Observation & Suspicious Activity Recognition) seminar sponsored by the NYS Police.
